Definition of processing activities

YOYO Suggestions provides users with various reminder services as part of the mobile phone system to improve the usability of Honor mobile phones.

This assessment covers only the use of the product in China and for Chinese users and only assesses whether, in the context of such use, the above evaluation standard would be met if this would apply for China. No assessment of any applicable law in China is made. Any use of the product outside China or within Europe or any use that affects users outside China or in Europe is not the subject of this assessment.

The following functions are subject to this evaluation:

- **Flight**
Enables the user to view real-time flight information (check-in time, boarding gate, baggage carousel, etc.) as well as one-click check-in to select seats and show boarding passes.
- **Subway Pass**
Providing subway boarding code automatically when the user is near the gate of a subway station.
- **Express Pickup Reminder**
Reminds the user to pick up the package on time through desktop cards, voice mails, notifications, etc.
- **Active Translation**
Allows translating the content copied by the user into another language.
- **APP Suggestions**
Provide the user with suggestions on various apps that they frequently use
- **Smart split screen**
Enables the user to display two application windows on one screen at the same time, and drag and drop images, text or documents directly between applications.

Annex 2 to certificate no. 427/22

Excluded processing activities

The product is intended for use in China only and not in Europe. The evaluation therefore only can be made whether the use of the product in China exclusively would be according to the evaluation standard if this standard would apply for China.

Only the functions of YOYO Suggestions listed in separate sheets (Flights, Subway pass, Express Pickup Reminder, Copy to Translate, APP Suggestions and Smart Splitscreen) are in scope.

Out of Scope:

- All processing activities relating to the User Experience Improvement Programme.
- Any processing activities relating to advertising.
- All YOYO Suggestion functions other than Flights, Subway pass, Express Pickup Reinder, Copy to Translate, APP Suggestions, Smart Splitscreen.
- Only the sub service "Copy to Translate" of the "Copy & Go" function is in scope. Apart from that, the function "Copy & Go" is out of scope.
- Any data processing of Payment platforms like Alipay or Wepay or platforms that will deal with payment information like bank details and any processing of payment information including bank details.
